

# Draft Minutes St. Martha's Episcopal Church Bethany Beach, Delaware Annual Meeting Draft Minutes November 19, 2023

**Quorum.** Secretary John Short noted that a quorum was present.

**Opening Prayer.** Rev. Ria began the meeting with a prayer.

**Call to Order.** Secretary John Short called the meeting to order.

**Approval of the Minutes.** The Minutes from the 2022 Annual Meeting were approved.

**Election of New Vestry Members.** After the nominations committee presented the nominees for the new Vestry, and on a motion by Tempe Steen and a second from Tina Edgar, the Vestry elected by acclamation Pat Leskowitz, Frank Marchand, and Marianne Pena as the new Vestry members.

Election of delegates and alternates to the 2024 Diocesan Convention. Caryn Cleveland-Short and Wendy Ray were elected as delegates to the 2024 Diocesan Convention. Bud Palmer was elected alternate.

**Rector's Report.** Rev. Ria referred members of the congregation to her written report.

**Senior Warden's Report.** Senior Warden Mary Davis had provided a written report.

## Finance Committee, Treasurer's Report and Budget.

Ron Kerchner, treasurer, reported that that church has healthy balances in our accounts. He also reported that \$100,000 has been deposited into a money market account and noted that the church's return on investment for the Master Fund A has been 8% and 4% for the Lighthipe Trust. He noted that the 2023 plate and pledges were \$68,000 ahead of last year at this time and were \$21,000 ahead of what has been budgeted.

# **Finance Committee Report.**

Finance Committee Chair Dave Moore noted that the use of an approved internal audit system had saved the church approximately \$20,000.

**Approval of the 2024 Operating Budget.** Dave presented the church's 2024 budget which had been approved by the Vestry and which was approved by the congregation.

Dave reviewed the 2024 church budget that had been approved by the Vestry. He distributed and reviewed pie charts that demonstrated the sources and amounts of income as well as the categories and amounts of anticipated expenditures for 2024.

**Stewardship Report.** Bill Freund gave the Stewardship Report and provided an update on the number of pledges and the amount that had been pledged. He reported that in 2022 the church received 109 pledges totaling \$219,000, which were the highest ever recorded. As of the date of the Annual Meeting, the Stewardship Committee received 88 pledges for a total of \$199,000. He also noted the importance of the pledges to the operation of the church and to the ability of St. Martha's to provide good works in the community. He thanked the congregation for their pledges and their generosity.

**Special Vestry Meeting.** A special meeting of the new Vestry will be held immediately following the Annual Meeting. The Vestry will include new members Pat Leskowitz, Frank Marchand and Marianne Pena, with continuing members Tim Lush, John Short, Rick Legeer, Sandy Roberts, Al Thomas, and Dave Moore.

**Adjournment and Concluding Prayer.** The meeting was adjourned and ended with a prayer.

## **RECTOR'S REPORT**

Dear Sisters and Brothers in Christ,

This is now the beginning of our fourth year together as Priest and People of God at St. Martha's in Bethany Beach. My work and ministry with and among you continues to be the highlight of the many years I have served in ordained parish ministry, and I consider it a blessing and a joyful privilege to love and serve Christ together with all of you. And I am very happy to tell you that we have surely done some wonderful work and ministry together in this past year.

St. Martha's continues to experience the blessing of a modest growth in numbers and membership. Our Average Sunday Attendance (ASA) numbers for these past years are as follows:

While these numbers are by no means breaking any records, they are still pretty amazing since we live in a time and place in which most churches are experiencing exactly the opposite. I am very grateful to God for our continuing success. And what that says to me is that we must be doing a pretty great job of living the gospel together!

Sacramentally, we have celebrated the lives of five dear souls: Robert Poetsch, Bill Roberts, Wally Watson, Michael Hurley and Arline Bucci. We have joyfully blessed the marriage of Loanne Pope and Alynada Pondes. And we have lovingly baptized Charlotte Rosemarie Casale.

Once again, this year, we have celebrated many "special" Sundays, so many in fact that nearly every Sunday seems special (which, indeed, it is!). During the past twelve months, we have celebrated a New Members Sunday, a Quilts of Valor Sunday, two Brick Blessing Sundays, Mothers' and Fathers' Day Sundays, Pet Blessing Sunday, Peace Pole Dedication Sunday, Remembrance Sunday and, of course, Holy Week, Palm Sunday, Easter, and Christmas Eve services. We welcomed our Bishop for his annual visitation in mid-September. And we welcomed people from all walks of life to join us during "tourist season" here at the beach.

There were some brand-new additions as well. We had our first "Blue Christmas" service last December. It was a lovely, and very well received, so that will no doubt become a new tradition here at St. Martha's.

We have launched a new Healing Prayer Ministry, with trained ministers now available during Communion at most Sunday services to offer brief private prayers with those who want them. I am deeply grateful to our Healing Prayer Ministry team for their compassionate desire to serve us in this beautiful way.

We have also launched a new Church School, which is small but mighty and offers our youngest members some age-appropriate faith formation during the ten o'clock Sunday Service. I am so very grateful to Deacon Chris and to all the Church School volunteers for getting this initiative off the ground in fine fashion.

And, speaking of Deacon Christ ... how lucky are we to have her with us?! She has continued to grow her ministry in the fertile ground of St. Martha's, and we are very fortunate and grateful to have her living her diaconal ministry among us.

All our ministry teams continue with their amazing work. I am particularly thankful for the liturgical team, aka Worship Committee, for their work in helping to provide beautiful and meaningful liturgical experiences for us all. # BUILDINGS & GROUNDS REPORT - Nov. 2023 to Oct. 2024

2024 was a relatively quiet year for Buildings and Grounds with no major capital projects undertaken or major repairs needed, just ongoing maintenance and checks.

**HVAC** - Arctic conducted semi-annual inspections and made repairs replacing several start run capacitors and exhaust pipe on HVAC unit.

**Crawl space** - Brasures conducted semi-annual checks and replaced batteries in monitors. Temperature and humidity readings have been in the normal range all year. Sump pumps worked properly.

**Electrical and Kitchen appliances** - Arctic electrician converted all inside and outside fluorescent fixtures to LED. He also repaired track lighting in the sanctuary. Jim and Mike installed additional track fixture for bell choir.

**Fire Systems & Extinguishers** - B&G Fire Equipment checked and recertified all fire extinguishers.

**Plumbing** - Jim repaired leaks in Ladies bathroom.

**Building Exterior** - Schuyler cleaned out gutters and installed gutter guards. Jim and John installed Memorial bricks. Jim replaced several outdoor trash cans and reconfigured trash can enclosure.

Brasures sprayed for pests and performed termite inspection.

**Building interior** - Jim replaced chair rail in the parish hall to prevent tables from damaging the walls. Jim removed altar railings to enable installation of new carpet.

#### **B & G CONTINUED....**

To support the hanging of the Justice quilt for the Becoming Beloved Community Committee, Jim moved the crawl space monitor. Jim hung the Framed Justice quilt and patched and painted holes. Keith Smith refinished cabinet placed beneath the Justice quilt which now houses excess books and other items out of sight. Clem ordered and hung bulletin board in the parish hall to display activities of the Becoming Beloved Community Committee.

Jim assisted Mac Goekler in installing the Peace Pole at the corner by the bike rack that Mac donated to St. Martha's.

Security Instruments inspected and tested all smoke detectors and alarms systems.

Jim installed doorstops to most interior doors. Jim removed the nonworking door mechanism in the foyer, had a machine shop repair it and reinstalled it. Jim worked on other door latches and planned sticking doors.

Jim secured the organ bench seat risers with L brackets.

**Landscaping** - Bethany Blooms performed fall, 2023 cleanup, and salted, walks, landings and steps. In the spring, they performed cleanup and mulching, mowed lawns and fertilized and sprayed for weeds. They removed the stump of an old holly bush Jim cut down.

Rowe Property Maintenance tested and adjusted irrigation. They replaced several broken sprinkler heads.

Jim planted donated oak leaf hydrangeas and replaced a dying rose bush as well as digging up spreading cannas to share with parishioners. Jennifer and Meg kept the grounds free of weeds, planted dozens of flowers they donated, and trimmed dead plants, pruned bushes and blew off debris.

#### **FINANCE COMMITTEE REPORT**

#### **Committee Members:**

#### **Purpose:**

The Finance Committee prepares the Annual Operating, Mission, and Capital Expenditures (Cap Ex) Budget proposal to the Vestry for its approval. The Committee seeks input from the various committees/groups to meet the physical needs and the program requirements of St. Martha's Mission Statement. In July, the Committee does an in-depth first half Operating, Mission, and Cap Ex Budget review, making proposed changes to the Vestry if needed.

Finance meets monthly during the year to review the Nilsson accounting firm St. Martha's financial reports and make recommendations to the Vestry regarding the parish's income and expenses. Finance also reviews the Diocese Master Fund A investment monthly reports for all St. Martha's Unrestricted and restricted accounts.

The Finance Committee prepares and reviews the Policies & Procedures for conducting St. Martha's financial affairs. These documents are sent to the Vestry for approval or revision. Finance follows the procedures as found in the "Manual of Business Methods" as developed by the National Episcopal Church. The Annual Parochial Report Financial section is prepared by the Finance Committee for Vestry approval.

The Committee has the task of scheduling the annual review of the parish's financial records. The financial review for calendar year 2023 was conducted by an Internal Financial Review Team (IFRT) (Wincy Jackson, Carl Long, and Beth Maurer) per vestry and diocese approval. The IFRT saves St. Martha's approximately \$20,000 annually in external audits fees. When this internal financial review was completed in June, the Finance Committee reviewed the report from the IFRT and made recommendations to the Vestry as needed. As required by diocesan canon, the written financial review report with supporting documentation was submitted to the diocesan office and accepted.

## **Accomplishments:**

- Approved recommended service for the church's handbells at a cost of \$3,900
- Approved purchase and installation of equipment and software from Mid-South Audio to facilitate hybrid meetings in the parish hall at a cost not to exceed \$1,300.00.
- The Credit Card process was updated to provide the monthly credit card transactions in the first week of the following month.
- The 2024 Operating and Mission Budget was reviewed in July with no changes.
- A Reserve Study Contract was completed in 2023 confirming a \$25K annual contribution going forward.
- Funds of \$10,000 for the Scholarship Committee to support planned programming were proposed and approved by Vestry.
- A separate St. Martha's laptop for the Asst. Treasurer to ensure cybersecurity to St. Martha's cloud.





#### **WORSHIP COMMITTEE REPORT**

Under the direction and guidance of The Reverend Victoria Pretti, Rector, the worship committee consisting of Nancy Rojewski (leader), Deacon Chris Miller-Marcin, Beth Maurer, Marianne Pena (greeters), Sandy Roberts, Diane Gay & Carolyn Smith (altar guild), Alice Ann Freund, Pat Long (flowers), and Dave Kemper (music), met in January, April, September and November. The committee reviews the church calendar and discusses worship offerings based on the liturgical seasons. We look at the "nuts and bolts" of things. We review and discuss upcoming worship opportunities and share information to ensure that worship goes smoothly.

In 2023 we had our regularly scheduled Sunday service at 8:00 and 10:00. We continued with Ash Wednesday service, a mid-eastern potluck meal and Maundy Thursday service of foot washing and communion in the parish hall, the blessing of the animals service, the candle lighting service for All Saints Day (Remembrance Sunday), Good Friday, Palm Sunday, Easter (8:00, 9:30, 11:30), and Christmas Eve (5:00). A Blue Christmas service was added. The Healing Prayer ministry was initiated and made available each Sunday during communion time to pray with individuals. The 10:00 Sunday service continues to be available through YouTube. A new baptismal font was made and blessed. New carpet on the altar platform was installed and a new lectern is forth coming. Deacon Chris and parishioners began a church school.

The committee continues to creatively look at ways to enhance our worship experience and help ensure that St. Martha's is a welcoming, loving community in which to worship.

# **OUTREACH COMMITTEE:** Co-Chairs: Fran & John McElvey

#### PROJECTS 2024:

**MISSION**: The Outreach Committee of St. Martha's Church shall display the love of Christ by sharing our resources with others to help improve the quality of life for those in need in our community.

**COMMITTEE MEMBERS:** Susan Callahan, Bill Gay, Florence and Steve Hawald, Fran Karns, Gayle Fontaine, Pat Leskowitz, Josie Legeer, Fran and John McElvey, Carol Miles, Caryn Cleveland-Short, Dale Smith, Dominic Thompson and Mary Thompson

**ANGEL TREE:** The Outreach Committee ask parishioners to buy gifts of clothing, art supplies, or a toy for a child from Phillip Showell, John Clayton, or Selbyville Middle School. Parishioners choose an Angel or Snow Buddy from our Christmas tree. School, gender, grade, and sizes will be on the cutout. Monetary donations are accepted if the parishioner would prefer an Outreach member to shop.

**BACKPACK AND SCHOOL SUPPLY DRIVE:** Parishioners donated \$2720 for backpacks and school supplies. Outreach delivered 24 backpacks and school supplies, including headsets, tissues, and Clorox wipes, to Phillip Showell and John Clayton Elementary schools. We also delivered 12 backpacks and needed school supplies to Selbyville Middle School, as well as socks, underwear, sweatshirts, pants, shirts, to students in need at SMS. \$118.64 in toiletries were also donated to the nurse's office.

**BETHANY BEACH VOLUNTEER FIRE DEPT AND BETHANY BEACH POLICE DEPT**: St.Martha's church appreciates the services of our local police and fire departments. Outreach donated \$500 to each department in 2024.

**CAMP ARROWHEAD:** Outreach donated \$10,500 toward scholarships for students to go to camp this summer. 14 students were able to attend with scholarship support from St. Martha's. Three students were Nanticoke students.

**CLOTHING OUR KIDS:** \$2000 was donated to this local organization which provides clothing to children in need in Sussex County. The organization gives the clothes to school counselors and nurses to be distributed as needed.

**CODE-PURPLE SHELTER:** St. Martha's Outreach donated \$1500 to support the homeless shelter in Georgetown through Love Inc./Code Purple.

**CROP HUNGER WALK:** St. Martha's Episcopal Church is one of several churches in the Ministerium to participate yearly in the Crop Hunger Walk. St. Martha's Church donated \$1,175 to Church World Service for the Crop Hunger Walk. \$1,000 came from the Outreach budget. Area food pantries receive 25% of the donations from the Crop Walk and the rest of the donations support just and sustainable responses to hunger, poverty, displacement, and disaster globally through Church World Service (CWS).

**DELAWARE HOSPICE:** A donation of \$1000 was made to Hospice of Delaware which provides comfort and care to the terminally ill and their families.

**DIAPER DRIVE:** St Martha's congregation donated \$535 toward diapers and personal items. Outreach purchased and delivered the diapers to IRSD Pantry and Union Wesley UM Pantry.

#### **EDUCATION AND CHILDREN'S NUTRITION:**

**FOOD FOR THOUGHT:** This donation goes into a fund controlled by the school cafeteria staff and is coordinated by the school counselor. All students can access the money if needed. It is also a way to provide healthy food for children who receive reduced or free lunch. Phillip Showell and John Clayton both received \$600 from Outreach in 2024 for their Food for Thought programs.

WHITE BAG LUNCHES: Outreach donated \$850 for the food program at Community Lutheran Church and \$139 for the white bags. This program provides bag lunches to food insecure students during summer vacation. One weekday, food is packed at Community Lutheran Church and taken to the Frankford Library where parents and students pick up the food. Food is delivered every weekday by different organizations. St. Martha's Outreach provides white bags and St. Martha's sketchers decorate the bags with artwork that appeals to the students.

**FOOD PANTRIES:** Outreach donates to four food pantries each month: Indian River School District (IRSD) Pantry receives \$500 in \$25 Food Lion gift cards and St. Vincent de Paul at Guadeloupe receives \$300 in Food Lion gift cards. Community Lutheran Food Pantry (CLFP) and Union Wesley UM Church Pantry receive checks for \$500 to purchase food each month for their pantries. \$400 is built into the budget for emergency

pantry needs. The total amount of money that St. Martha's church donates to food pantries is \$22,000 a year.

WINTER MEAL PROGRAM: St. Martha's Outreach participates with other churches in the Ministerium to provide meals for those in need from November until March. The meals are handed out at the Frankford Fire Department. St. Martha's Outreach takes water, snacks, and fruit to Mariners the second Tuesday of the month for about 50 people. The water, fruit, and snacks along with soup prepared at Mariners make a nourishing meal. Funds come out of the Outreach Emergency fund.

HABITAT FOR HUMANITY: Habitat preserves homeownership and neighborhoods by building and repairing homes in partnership with people in need of decent, affordable housing in Sussex County. Outreach donated \$2000 to Habitat in 2024. Outreach also donates Welcome Baskets with cleaning supplies to new homeowners. Many of St. Martha's Parishioners have attended the Habitat Home Dedication Ceremonies and presented the baskets. The cost of each basket is about This year Outreach purchased 9 welcome baskets for \$1606.92.

**HOME OF THE BRAVE:** Outreach donated \$1000 to The Home of the Brave Foundation, Inc. in 2024. This program provides targeted assistance regarding housing and counseling for homeless women veterans and their children.

#### INTERNATIONAL STUDENT COMMITTEE - BILL GAY

St. Martha's church hosted the 17th Annual Picnic on June 25. There were over 140 students from 23 different countries who attended. More than a dozen Community Partners and scores of generous businesses donated food. It was perfect weather for the event!

We hope the picnic food, swag, games, bike repairs, and a warm inclusive welcome will make memories that will inspire these Students to join us in efforts to create world peace as they become future leaders in their countries. And our volunteers certainly acquired some "feel good" memories, too, such as, the student who explained that he wasn't able to go to a school that taught English, so he taught himself English by watching YouTube. And the frantic business calling to say they were rushing over with a huge donation of "mac and cheese," but it would only be five trays because a tray fell in their driveway. Exhausted volunteers smiled as they watched students riding their bikes home at dusk with bags of extra food to share with roommates who had to work and missed the picnic.

MILFORD HOUSING DEVELOPMENT CORPORATION: Strives to provide decent, safe, and affordable housing solutions to people of modest means. Outreach donated \$2000 to MHDC in 2024.

**FAMILY PROMISE:** Outreach donated \$6000 to Family Promise in 2024. Family Promise helps families experiencing homelessness and low-income families achieve sustainable independence through a community-based response.

**OPERATION SEAS THE DAY**: Outreach donated \$1000 in 2024. During this week, Bethany Beach hosts soldiers and their immediate families for a well-deserved week of rest and relaxation as they stay in homes/condos donated by local homeowners.

**SOUTH COASTAL VILLAGE VOLUNTEERS:** Outreach donated \$1000 to SCVV in 2024. SCVV coordinates volunteers to assist members with services such as transportation to various appointments and shopping, home visits, telephone check-ins, running errands, technology support and small household tasks. Currently SCVV serves residents within the ZIP codes of Bethany Beach, Millville, Ocean View and South Bethany.

#### **QUILTS OF VALOR:** St. Martha's Stitchers and Sketchers

In 2024, the Stitchers made progress on several Quilts of Valor but did not award any. In the spring, two Stitchers attended a panel on homelessness put on by the Becoming Beloved Community. A counselor at Selbyville Middle School spoke of the dire situation her displaced students and their families are in. In response, the Stitchers donated 25 quilts last spring to the counselor to distribute to these families. Another 20 quilts are being finished and will be donated by the end of 2024. The Counselor reports that her students are thrilled to receive these quilts. The quilts are going to families who may have housing but very little else who may not have adequate heat as well as to displaced families.

Two other quilts are being donated to Family Promise and to the Sons and Daughters of Italy-Ocean City to use as fundraisers in support of their charities. The Stitchers have also been busy making baptism quilts for our newest parishioners.

Materials and labor are estimated at \$600 per quilt.

**SOUTHEAST SUSSEX MINISTERIUM (SESM):** Outreach donated \$6000 in 2024 to the Ministerium to help people in Sussex Country who need assistance with their rent, utilities, and/or medical needs. The Pyle Center meets with people in need and then refers them to the Ministerium for their emergency needs.

**STOCKLEY CENTER-**The Episcopal Churchwomen of Delaware ministry is to provide birthday cards and Walmart gift cards to disabled residents at the Stockley Center. St. Martha's Outreach provides \$25 gift cards to Walmart and birthday cards for four residents with December and January birthdays. Outreach also contributed \$215.30 worth of needed toiletries for residence.

**THANKSGIVING DINNERS:** Parishioners provided Thanksgiving meals of specific food items to 30 needy families from John M. Clayton Elementary, Phillip C. Showell Elementary, and Selbyville Middle School. Outreach also included a \$30 Food Lion gift card in each bag for turkeys.

**THE WAY HOME:** This facility in Millsboro provides inmates released from the Sussex County Detention Center a temporary residence, guidance, and support as they transition back into the local community. Outreach donates \$16,000 yearly to The Way Home. An additional \$68.20 in donations of toiletries and clothing were also given to TWH.

#### **EMERGENCY FUNDS:**

- In collaboration with Mariner's Bethel and other churches from the Ministerium, St. Martha's Outreach donated snacks, water, and fruit for 50 people once a month from November to March for a Winter Meal Program. The meals are given out at the Frankford Fire Department on Tuesday evenings. \$88.68 was used for these snacks.
- Outreach also donated \$250 for snacks for Selbyville Library summer program.
- Outreach donated \$1000 to Contractors For A Cause which helps families stay in their homes by providing ramps and fixing homes.
- Stockley Center donations for toiletries, birthday cards, and gift cards for 4 residents. \$215.30 came out of Miscellaneous Funds.
- The Way Home toiletries for \$68.20 also came out of Miscellaneous funds.
- The Crop Walk donation from Outreach was \$1,000.

- Outreach also donated \$1,200 to Higher Ground Outreach, Inc. which provides meals, clothing, and daytime shelter to the homeless in Georgetown. They requested help for rent on their building until their grant came through.
- Outreach donated \$393.46 to help a family in dire need with utilities.

#### **ADDITIONAL INFORMATION:**

**COMMUNICATION:** Outreach informs the congregation in several ways. There is a section for Outreach news in the Wednesday Information emails and announcements are often made on Sunday at the church service and special events are in the bulletin. Outreach displays are also on the walls in the Parish Hall.

**SCHOOL COUNSELORS**: Counselors have kept Outreach members informed when there is a special need at the schools. Counselors also provide Outreach with "names" of the families who need Thanksgiving Meals and Angel Tree gifts.

**MENTORS:** Several parishioners, including some Outreach volunteers, mentor in local schools.

The Outreach Committee thanks the people of St. Martha's who have given so generously of their time, money and donated goods in support of the above charities and thus truly reflect, "Love God, Love your Neighbor, Change the World".

#### **MUSIC REPORT – DAVE KEMPER**

As I complete my 12<sup>th</sup> year as Director of Music at St. Martha's, I reflect on the many changes that have taken place during this time. I also think about everything that has remained constant. The people of St. Martha's remain warm, loving, and welcoming. #### **BECOMING BELOVED COMMUNITY COMMITTEE**

The Becoming Beloved Community Committee has been very active in the 2024 calendar year, planning, offering and sponsoring programming related to our mission: to highlight issues related to marginalized people through sharing knowledge, fostering understanding and empathy, and taking direct action to promote social justice.

For January, the Committee sponsored a program on Fair Trade and the importance of economic justice and paying people a living wage for products that are imported into this country. Our February programs consisted of the placement and blessing of St. Martha's Justice Quilt that had been displayed at the Diocesan Convention, and a commemoration of Absolom Jones Day, with these events occurring on Sunday, February 13, 2024. Another very successful program consisted of a dramatic reading of "The Diary of Anne Frank," which was co-sponsored by the Adult Education and Community Events Committee. The Hispanic American Association of Delaware's Ballet Mexico Lindo dance performance, featuring both children and adults, was the final program in February.

A panel discussion on "Homelessness and the Lack of Affordable Housing in Southern Delaware was the BBC Committee's program for March. The panelists included representative from the Family Promise of Southern Delaware, a state senator, representatives from the Indian River School District, a volunteer and interpreter from Habitat for Humanity in Sussex County, and a representative of the Springboard Collaborative and the pallet village concept of transitional housing.

The months of April through August were devoted to discussions related to social justice issues and planning for future programming.

In conjunction with Music Director Dave Kemper's summer music series the Committee co-sponsored a performance by Ms. Maya Belardo, an African American jazz vocalist, and her band in September. BBC and the Adult Education committees also sponsored a viewing/discussion of the documentary film, "God & Country. In September. October events included the installation, dedication and blessing of St. Martha's Peace Pole.

The Committee will highlight Native American Heritage Month with written inserts and other sharing of information with the congregation in November. A final planned event for the year will be a dramatic reading of the play "Inherit the Wind" in November.

Programming and activities related to Black History and American Indian history is well underway for the 2025 calendar year.

#### **CARD MINISTRY**
